

### MICHIGAN GAMING CONTROL BOARD RELEASES <u>AMENDED</u> APRIL 25, 2017 REGULAR PUBLIC MEETING AGENDA

On April 20, 2017, the Michigan Gaming Control Board released an amended regular public meeting agenda for April 25, 2017. Changes are highlighted below.

# FIREKEEPERS CASINO HOTEL ANNOUNCES GRAND OPENING OF THE FIRE HUB RESTAURANT AND FOOD PANTRY

On April 19, 2017, FireKeepers Casino Hotel marked the Grand Opening of its Fire Hub restaurant and Kendall Street Pantry. The opening ceremony included Michigan Governor Rick Snyder, the Nottawaseppi Huron Band of the

Potawatomi Tribal Council along with additional elected officials and Michigan business partners.

"The Fire Hub will help meet basic needs for people and is a great example of community revitalization and working together to help one another," said Governor Snyder. "Strong, vibrant communities require teamwork and a shared commitment to a brighter future."

The project, originally announced in May of 2016, is a multi-million dollar investment in the Battle Creek community in which 80 percent of profits will be pooled to benefit local charities in addition to a food pantry working in conjunction with the Food Bank of South Central Michigan, for those less fortunate. Another major element of the project is the development of nearby tribal lands to farm and grow vegetables, with a goal of delivering a free salad bar to students in area communities.

"The Nottawaseppi Huron Band of the Potawatomi ("NHBP") is honored to lead this amazing community initiative," stated NHBP Tribal Council Chairman, Jamie Stuck. "We can deliver the region's best casino resort product while simultaneously improving the lives of local residents. Supporting the local community has always been a priority for us and today's Grand Opening is the successful collaboration of the tribe's community focus, Chef McFarlen's vision and the dedicated efforts of the Food and Beverage team at FireKeepers Casino Hotel."

The Fire Hub restaurant will be open Tuesday to Saturday from 6 am to 6 pm, in Battle Creek, and will offer a variety of menu items such as freshly made bread and muffins, breakfast items, soups, salads, hot and cold sandwiches, pizzas and desserts.

## CASINO INDUSTRY IS ESSENTIAL TO SMALL BUSINESS GROWTH, AGA SAYS

On April 20, 2017, the American Gaming

Association ("AGA") released a new research study titled, <u>The Gaming Industry's Impact on Small Business Development in the United States</u>, which states that the casino gaming industry is driving small business growth across the country.

### According to the study:

- Casinos are responsible for \$52 billion in annual small business revenues across real estate, finance, health care, STEM, manufacturing, information technology and other industries:
- Casinos support roughly 350,000 small business jobs;
- Casinos support \$13 billion in small business employee wages;
- More than half of casino industrysupported jobs are at non-gaming business such as local restaurants and shops that see an increase in traffic from a casino property; and
- Researchers concluded that gaming's widespread impact is felt in markets across the country, but has outsized impact in small to mid-sized communities where local businesses work to integrate into gaming operations.

"Gaming is a small business driver and champion," said Geoff Freeman, President and CEO of AGA. "This new report makes clear that the industry is a critical force behind good paying American jobs from coast to coast."

The report was commissioned by the AGA and conducted by Spectrum Gaming Group which examined nearly a dozen gaming markets in the United States and assessed casino gaming's impact, both direct and indirect, on local small businesses.
