ATTORNEY GENERAL AND DEPARTMENT OF JUSTICE FILE NOTICE OF APPEAL IN WIRE ACT CASE

Today, the United States Attorney General William Barr and the Department of Justice filed a Notice of Appeal in District Court challenging the June 20th New Hampshire Federal District Court decision which had rejected their interpretation of the Wire Act's application to online wagering, appealing the decision to the First Circuit Court of Appeals. *New Hampshire Lottery Commission, et. al v. Attorney General of the United States of America, Case No. 19-CV-00163-PB*

In January 2019, the Department of Justice ("DOJ") issued a Wire Act Opinion ("2019 Opinion") that reversed a prior 2011 DOJ Opinion that held that the Wire Act only applied to sports gambling. In response to the 2019 Opinion, the New Hampshire Lottery Commission brought suit, arguing that the 2019 Memo was incorrect as a matter of law and that if enforced, would shut down New Hampshire's online lottery sales. Multiple states, including Michigan, as well as industry groups have filed amicus briefs and participated in oral arguments. NeoPollard Interactive (an online lottery service provider) also filed suit making similar arguments, and the District Court consolidated the cases.

On June 3rd the District Court issued an Opinion holding that the Wire Act does not apply to forms of online gambling other than sports gambling and rejecting the DOJ Opinion. A motion for reconsideration was filed and the Court denied that Motion on June 20th. The appeal now moves the case to the First Circuit Court of Appeals which will review the legal decisions of the lower court. The case could have major implications for all forms of online gaming, including state lottery activities online.

MICHIGAN GAMING CONTROL BOARD RELEASES DETROIT CASINO REVENUES & WAGERING TAXES FOR JULY 2019

In a [press release](#) dated August 14, 2019, the Michigan Gaming Control Board (“MGCB” or “Board”) released the July 2019 revenue figures for the three Detroit casinos – MGM Grand Detroit Casino, MotorCity Casino and Greektown Casino.

The three Detroit casinos reported \$119 million in aggregate revenue for July 2019, a 0.3% decrease from the same month last year. The results were 1.3% above the monthly revenue in June 2019. The year-to-date aggregate revenue of \$854 million was 0.8% higher than in the first seven months of 2018.

Revenue increased at MGM by 1.5% to \$51.7 million. MotorCity recorded a revenue increase of 0.3% to \$40.7 million. Greektown revenue decreased by 4.3% to \$26.6 million compared with July 2018 results.

The July 2019 market shares for MGM Grand Detroit, MotorCity Casino and Greektown Casino were 44%, 34% and 22% respectively.

During July 2019, the three Detroit casinos paid \$9.64 million in gaming taxes to the State of Michigan, compared with \$9.6 million for the same month last year. The three casinos reported submitting \$14.2 million in wagering taxes and development agreement payments to the City of Detroit in July.

All three casinos are subject to a wagering tax of 19%, with 10.9% of this levy payable to the City of Detroit and 8.1% payable to the State of Michigan.

The figures released by the Board are the gross receipts less winnings paid to wagerers. The

figures do not include: 1) any fees or other relevant city, state or federal taxes; 2) wages and benefits paid to casino employees; 3) payments to suppliers, services providers or vendors; nor 4) other normal business expenses.

MIDWEST SPORTS WAGERING UPDATE: INDIANA SET TO GO LIVE WITHIN 30 DAYS

As the state of Michigan continues to debate the legalization of sports wagering and other gaming expansion options, Indiana and Illinois have passed laws permitting wagering on sports. In Ohio there are two bills pending (HR 194 and SB

111) although passage does not appear to be on the horizon as lawmakers debate what the appropriate agency would be to oversee sports wagering, as well as other details related to its rollout.

Indiana is set to be the first neighboring state to authorize sports wagering. All indications are it will likely occur around the start of the 2019 NFL season. Under state law the first wager cannot be placed until September 1, 2019. In an article in the Journal Gazette, Jenny Reske, Deputy Director at the Commission stated: “September 1 is the first day the activity can be offered but there are a lot of regulatory steps that need to be accomplished prior to launch.” Noah Hirsh, Assistant General Manager for the Horseshoe Casino located in Hammond, Indiana told The Times that “construction is progressing on Horseshoe’s 5,300 square foot sportsbook.” He noted that work should be completed by Labor Day. The casino’s website states that the sportsbook will open in September, but no formal opening date has been announced.

By an [adopted Resolution](#), the Indiana Gaming Commission has given its Executive Director broad powers with regard to the implementation of sports betting. The Indiana Commission is set to review rules relating to sports wagering and to consider adoption at its August 28th public meeting set for 1 p.m.

Ms. Reske told the Journal Gazette that “there could be a two-tier rollout – retail betting at the casinos and OTBs followed by the online/mobile component.” The following casinos have been issued temporary certificates of authority to provide sports wagering to their customers:
